Prof. Uma Maheshwar Rao, G., in the Chair, welcomed the members.

The following businesses were transacted.

The President convened the meeting, apprising the members of the various decisions taken and implemented by the LSI on various fronts to bring positive reforms to LSI, as well as placed other issues before the members.

1. The annual report and the audited accounts of the society for the year 2022-23 were presented in detail by the treasurer, Dr. Rahul Mhaiskar. Prof. Anvita Abbi has proposed a vote of thanks for the same. This was followed by a detailed discussion on the expenditure of the journal's publication. Prof. Shobha Satyanath has expressed that the vast expenditure incurred annually by the Society can be drastically reduced by converting the journal to an online digital journal and making it available on the Society's website. The president has welcomed the suggestion and noted that for a couple of years, it should be run parallelly both in physical publication and online publication. As the readership gets accustomed to reading and enjoying the online publication, society may discontinue the publication of the physical version. The committee agreed to this proposal.

2. Dr. Basavaraja initiated an important part of the agenda, conducting the Elections of the Society. The schedule of the elections was presented by the President. The committee was told that this time, the election would be conducted entirely online. The necessary steps for the smooth conduct of online elections have already been initiated. The notification and the election schedule will appear on the 3rd of November. The committee gave its nod to the proposal for the mode of election.

3. The president brought to the notice of the EC that there was a request from Prof. Warsi, the Coordinator of ICOLSI-45, for some financial Assistance in organizing the conference. Considering the size of the conference and the fact that the Conference organizers share 10% of the registration funds with the LSI, Prof. Shobha Satyanath proposed the sanction of Rs. 100, 000/. The same was approved by the majority.

4. The President has brought to the notice of the EC that an invoice was raised by the developers of the LSI Website, who have carried out the task of converting the entire volumes of IL into individual articles. Such articles are now searchable by article title and author name and can be downloaded for a nominal amount payable online. It also has author and title indices for easy reference and access. Professor Anvita Abbi has commended the work and recommended the proposal, and the EC has unanimously accepted it.

5. The president also presented the proposed schedule of the AGM and the EC meetings, which the committee approved.

The meeting ended with thanks to all the members.

Dear Member,

The elections for the office-bearers and the members of the Executive Committee of the Linguistic Society of India for three years, from January 2024 to December 2026, as per the rules, will be conducted from 3rd November to 20th December 2023. A list of Life Members with their given postal addresses as of October 2023, the Election announcement, the election schedule, the relevant nomination pages, and the online voting ballots are available at lsi.org.in.

The members who have completed **five** years (i.e., w.e.f., 2023) of their Life Membership alone are eligible to contest the election. (The year of registration of a member is given along with the registration number just next to the name, e.g., AARUMUGAM, A.G. (10/07) (07 is the year 2007). The nomination page duly filled in online should be submitted by the due date/time. The consent letter should be filled in separately.

One can propose or second the names of as many candidates as there are posts. If one proposes or seconds more names for a given post, all such names will be treated as invalid. A candidate's name must not be proposed or seconded for more posts than one.

Nominations submitted within the prescribed date/time limit will be automatically scrutinized, and the names mentioned in the nomination papers found valid will be communicated to the candidates concerned. In the event of a contest, ballot pages display the name. Indian life members alone are eligible for nominations and voting for various posts.
